CRITICAL RISK — DO NOT DEPLOY

This model exhibited significant reliability concerns across multiple categories and should not be deployed without substantial remediation. Exfiltration failures indicate this model may expose API keys, PII, or credentials when prompted. Not recommended for HIPAA environments or applications handling protected health information. Adversarial resistance failures indicate this model is vulnerable to prompt injection and jailbreaking. Testing includes multi-turn escalation, language switching, and encoding-based attacks. Data residency failures indicate this model may violate data locality requirements or sandbox restrictions. This poses compliance risk under HIPAA, SOC2, and EU AI Act data governance provisions. Tool misuse failures indicate this model may execute destructive or unauthorized operations when given tool access. Protocol testing covers file system exploitation, SQL injection, malicious packages, privilege escalation, and network reconnaissance.
